

**MINUTES OF A SCHEDULED MEETING OF THE EUFAULA CITY COUNCIL HELD ON  
MONDAY, JUNE 15, 2020 AT 5:15 P.M.**

The Eufaula City Council met in a scheduled session on Monday, June 15, 2020, at 5:15 p.m. in the Police Department Courtroom at 545 East Barbour Street. Upon call of the roll the following members were present: Council President Johnny A. Knight, President Pro Tem Barbara Flurry, Lucious Cobbs, Linda Grice, and Tony L. Robertson.

Also present: Joy White, City Clerk/Treasurer, and Joel Smith, Esq.

Council President Knight called the meeting to order, and Bro. Don Dillard offered the invocation. Council President Knight led the Council and audience in the Pledge of Allegiance.

**HONORS AND RECOGNITION**

**APPROVAL OF AGENDA**

Mrs. Grice offered a motion to approve the order of the June 15, 2020 agenda. Mrs. Flurry seconded the motion. After a voice vote, Council President Knight announced the motion had carried.

**CONSENT AGENDA**

Council President Knight reviewed the items on the Consent Agenda for council approval.

- (a) Motion and second to dispense with and approve the City Council minutes of June 1, 2020.
- (b) Motion and second to approve the Prepaid Claims Docket dated May 31, 2020, in the amount of \$2,193,194.87.
- (c) Motion and second to approve the Claims Docket dated June 10, 2020, in the amount of \$59,902.63.

Mr. Cobbs moved to approve the Consent Agenda. Mr. Robertson seconded the motion. After a voice vote, Council President Knight announced the motion had carried.

**MAYOR'S REPORT**

Mayor Tibbs announced that the Industrial Access grant for paving the southern Industrial Park was approved in the amount of \$340,000. Several of the existing industrial businesses are expanding and there is promising potential of newly relocating businesses to Eufaula. Hyundai Poly-Tech is also expecting to provide approximately 200 jobs over the next three years. The owners of the Beaulieu building are donating the building to the City of Eufaula. The City of Eufaula has also applied for a joint EDA grant with the Water Works & Sewer Board that is awaiting approval. The grant will be designated to the repair of the infrastructure located in the southern Industrial Park. The street paving project has begun in the Forest Hills Subdivision and will continue throughout the city over the coming weeks.

Mayor Tibbs also announced that repairs are being completed at the local Weedon Field Airport to include work on the hangars, paving, and landscaping. The adjoining north property of the

airport has been purchased and is now a part of the Weedon Field Airport. Continual re-opening of businesses and new developments are taking place in the city.

**COUNCIL COMMITTEE REPORTS**

Mrs. Flurry reported that the budget was over \$770,000 from this time last year. There is a decrease in lodging taxes with a slight decrease in the local gas tax. Garbage collections are down from last year this time due to the termination of commercial garbage pickup. All departments are within budget.

Mrs. Grice reported that the Board of Education is making necessary changes due to the pandemic over the last several months. The Carnegie Library is continuing a gradual re-opening process, but continues to provide curbside service. Mrs. Grice commended Tim Brannon and Chris Dollar for devotedly serving the city.

Mr. Cobbs reported that the community center is continuing a gradual re-opening process and commended the airport renovations.

Mr. Robertson asked that everyone keep Tim Brannon in their thoughts and prayers on his path to recovery.

Council President Knight commended Police Chief Watkins, Fire Chief Feggins, and Chris Dollar for their service to the City of Eufaula. He also announced that the street paving project began today.
