

**MINUTES OF A SPECIAL CALLED MEETING OF THE EUFAULA CITY COUNCIL  
HELD ON TUESDAY, SEPTEMBER 1, 2020 AT 11:30 A.M.**

The Eufaula City Council met in special called session Tuesday, September 1, 2020 at 11:30 a.m. at the Police Department court room at 545 East Barbour Street. Upon call of the roll the following members were present: President Johnny A. Knight, Barbara C. Flurry, Lucious Cobbs, and Linda S. Grice. Absent: Tony Robertson.

Also present: City Clerk Joy White, Councilmember-elect Wes Register and Ms. Julie Hill, Barbour County Board of Registrars.

Council President Knight called the meeting to order and stated the purpose of the meeting was to address Resolution 85-2020 (Canvass Votes Municipal Election 08 25 2020).

City Clerk/Treasurer Joy White announced that there were some provisional ballots, and Ms. Hill explained that the Board of Registrars reviews all PB-3 forms and information to determine whether the ballots can be accepted for count or rejected. Ms. Hill also explained that a rejected ballot is often the result of a voter attempting to vote in a different district other than the district where they actually reside, or they have not provided valid identification. Mrs. White then proceeded to open the provisional ballots to be counted and verified.

The review of the votes and provisional ballots was completed. Mrs. Grice offered a motion that the votes and provisional ballots from the city election held on August 25, 2020 be accepted as counted, verified, and recorded. Mrs. Flurry seconded the motion. After a voice vote, Council President Knight announced that the motion had carried.

1. That Jack B. Tibbs, Jr. received a majority of the votes cast for the office of Mayor and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
2. That Ben Garrison received a majority of the votes cast for the office of Council Member, District 1 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
3. That Otis Hill received a majority of the votes cast for the office of Council Member, District 2 and is hereby declared duly elected to that office for the term beginning the first Monday in November, 2020.

4. That Wes Register received a majority of the votes cast for the office of Council Member, District 5 and is hereby declared duly elected to that office for the term beginning the first Monday in November, 2020.
5. That no candidate received a majority of the votes cast for the office of Council Member, District 4, and that Logan B. Mitchell and John Wayne Robinson received the most and second most votes cast for the office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 6, 2020 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
