AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, ARTICLE IV. ELECTRICAL CODE, SECTION 18-34 PERMIT FEES AND SECTIONS 18-131.

INSPECTION FEES

BE IT ORDAINED by the City Council of the City of Eufaula, Alabama, as follows:

- (10) Permit reactivation fee \$35.00**
- (11) Copy fees \$.50 per sheet**
- (12) Copy of Zoning Ordinance \$20.00**

SECTION 18-127 Application for permit.

Permit Valuation

Residential New Construction: Total square footage\$100.00= Value of construction.

Accessory Structures/Detached Garage/Etc.: Total; square footage X \$50.00= Value of construction.

Commercial New Construction: Total square footage X \$127.50= Value of construction.

SECTION 18-131. Inspection fees.

Reinspection fee: \$25.00
Inspection fee for temporary services-\$15.00

RESIDENTIAL/COMMERCIAL ELECTRICAL

Electrical permit issuing fee-\$25.00

New Service fee (Residential): up to 200 Amp \$30.00

All rewiring permit will be based on job value.

COMMERCIAL AND INDUSTRIAL

Minimum fee will be \$25.00. New Service \$0.25 per amp. Any additional fees will be determined by the electrical inspector.

RESIDENTIAL/COMMERCIAL PLUMBING

\$2.50 per opening
Plus \$10.00 issuing fee

RESIDENTIAL/ COMMERCIAL MECHANICAL PERMITS

Fee based on job value (see fee schedule), plus \$10.00 issuing fee.

SIGN PERMIT FEE

Fee based on job value (see fee schedule)

RESIDENTIAL/ COMMERCIAL GAS PERMITS

\$15.00 up to (6) outlet \$5.00 for each additional

MOVING BUILDING \$75.00

BUILDING DEMOLITION \$35.00

***** ADDITIONAL FEES *****

Act 2015-308-State of Alabama creating a "Construction Industry Craft Training Program".

****** CICT FEES****: The fee shall be equal to one dollar (\$1.00) for every one thousand dollars (\$1,000.00) of construction authorized. The fee shall apply to any non-residential building permit issued after October 1, 2016. This fee is remitted monthly to the State of Alabama Division of Construction Management.**
